

NCA Informed Consent, Release, Media Authorization, and Contact Form - REQUIRED FOR ALL PARTICIPANTS: Students, Teachers, Coaches, and Volunteers

For the purposes of this document, "NCA" shall be Northville Christian Assembly of God, and its officers, directors, employees, assigns, volunteers, and agents including any third party designated and approved by NCA at any time. As used below, "Participant" shall mean any individual, student, mentor, coach, teacher or volunteer involved in an NCA event. In acceptance of my participation in any NCA & related programs, meetings or events (collectively, the "Event"), I agree to the following:

I, the Participant, hereby grant to NCA the right to photograph and/or videotape me during my participation in an Event. I further grant to NCA the right to use these photographs and videotapes of my likeness, voice and sounds during my participation, and to license the right to reuse such photographs and videotapes of my participation, and my name, likeness and biography, in any and all media for any purpose, including advertising and other promotions of NCA without compensation to me. Each such photograph and videotape shall be a work for hire and NCA shall be deemed the owner of any copyright and/or trademark rights therein. NCA may use my information for their program promotions.

The undersigned being fully cognizant of the risks in participating in an Event, hereby assumes the risks of bodily injury and property damage, inherent in such participation. I hereby waive any claims or causes of action which I may now or hereafter have against NCA, arising out of my participation, and I will indemnify and hold harmless NCA against any and all claims resulting from such participation.

I hereby further release NCA from any and all liability for damages of any kind or nature that may at any time result to the participant during any and all activities. I understand that ALL precautions concerning participant's safety will be of the utmost concern for those that are running this activity. I also understand that transportation to and from all events may be provided by rental vehicles or privately owned vehicles if needed.

Further, I will not hold NCA liable for any lost or stolen articles. I hereby declare that the participant is and will be covered by his or her parent's health insurance policy during travel and for all activities.

I agree to be bound by the policies of Northville Christian Assembly of God. I also agree to talk to my child about their behavior. I understand that in the event my child has caused a problem for the group, the leaders may call me and I will be responsible to pick them up and take them home. The applicant agrees to refrain from unscriptural conduct in his/her participation in all activities, on behalf of the church.
